

Rules and Regulations of Independent Business Associate

1. Oriens Global Marketing Pvt Ltd Co is incorporated under Indian Companies Act 1956, registered with Registrar of Companies, Chennai.
2. The applicant must be an Individual/Partnership Firm/Pvt Co/Proprietorship, and on successful completion of registration he/she/It will be called as an Independent Business Associate (IBA).
3. During Registration an Individual must submit respective Identification proof copy and Partnership Deed or Company registration copy in case of Firm/Pvt Co/Proprietorship.
4. The Partnership Firm/Pvt Co/Proprietorship must submit the Power of Attorney to any one person who can deal and correspond with company. He / She must be an IBA.
5. The Individual must be a major and should have the legal capacity to contract independently to conduct the business of Oriens.
6. All the Business Associates must keep their code of conducts and business ethics of the company.
7. An Independent Business Associate has the right to buy, sell, and promote the Oriens products globally.
8. The Independent Business Associate has the right to purchase the product under Distributor Price (DP), and must sell it under Companies MRP only. He / She / It should not sell under or over the maximum retail price (MRP).
9. The IBA must sell the products through Multi Level Marketing only.
10. The Independent Business Associate enjoys the margin of 10-20 % on DP.
11. All the Prices are inclusive of Taxes. The taxes, duties, levies are as per the procedure applicable of the Law of the Land.
12. The Independent Business Associate shall abide by sales policy and procedure of the Company as amended from time to time. The Company shall not be responsible in any manner what so ever to the Independent Business Associate or third party for any dispute, claims or loss as a consequence of Independent Business Associate non-compliance with the sales policy of the Company.
13. The Independent Business Associate will enjoy the Bonus/Incentives according to his/her own or team Oriens business and the rates will be applicable as mentioned in Companies Business plan.
14. The Bonus will be paid twice in a month after deducted necessary taxes, TDS as per Indian Income Tax Act.
15. PAN Number is compulsory for receiving Bonus
16. On any case the Individual should not apply for another IBA ID, if doing so the second ID will be terminated automatically without transfer any business to the first ID.
17. Independent Business Associate should not represent him/herself as an employee of Oriens and should not use its stationary, logo, trademark pertaining to Companies Identity. There is no agency or employment relationship with Company.
18. The Company is not responsible for the relationship between IBA and Stockiest for any of their past, present, future liability incurred on their individual capacity while selling Oriens products.
19. The IBA must promote the Oriens Products as per the guidance, information given in the Companies printed material and shall not promote any revision and amendments in it.
20. The cross sponsoring of Business Associates is not allowed, if doing so the second IBA ID business will be terminated without any notice.
21. An Individual who paid registration through online must submit the ID Proofs, PAN copy duly with registration copy print out to the Stockiest Office directly.
22. The Company reserves all the rights to terminate an IBA who is not comply with rules and regulations and act against the business ethics there to without giving any prior notice.
23. The Company does not entertain any direct sales, all the sales transactions are routed through our authorized Stockiest only.
24. By signing or authorizing the application form the Independent Business Associate expressly agrees, abides and bound by the rules and regulation of the Company.
25. All the disputes and differences there to or arising shall be adjudicated upon by a court of appropriate jurisdiction at Chennai only.
26. Oriens reserves all the rights to change, amend the policies, rules, regulations, and business plan time to time and governing the conduct of distributor and its decision in this regard shall be final and binding on distributor.
