

AGREEMENT BETWEEN BUSINESS ASSOCIATE & INTERNATIONAL MARKETING CORPORATION PVT. LTD. (in short IMC)

An Associate is expected to be truthful and accurate in offering IMC Business opportunities or selling IMC Products. He should not make false claims about the quality, uses, opportunities, products, earnings & efforts required to build the business.

An Associate can own and operate one Associationship only. A husband and wife can be sponsored only as a single Associationship.

Business Associate will keep in confidence all trade secrets and agrees not to enter or participate in a competing business activity in any direct selling company.

Associate hereby confirms that he/she has entered into this Agreement as an independent contractor. Nothing in this Agreement shall establish an employment relationship or any other labour relationship, between the Associate and IMC and nothing shall establish the Associate's position as procurer, broker, commercial agent, contracting representative or other representative of IMC when purchasing and selling IMC products, the Associate shall act as an independent vendor, acting in his/her own name, at his/her own responsibility and for his/her own account.

An Associate in one line of sponsorship must buy all the products either directly from IMC or from his/her sponsor. No Associate shall engage in Cross-group Selling.

An associate must not engage in any deceptive or unlawful trade practice as defined by any Central, State or local law or regulation.

No Associate can introduce Produce or sell any business support material without the consent or approval from IMC.

When there is a dissolution of Associationship, the incentive will be divided equally among the Business Associates or as decided by the Court.

This agreement is entered into on a personal basis and may not be assigned or transferred by the Business Associate to a third party without IMC prior written consent.

IMC may reject this application for any reason, at its discretion, including if the application contains incomplete, inaccurate, false or misleading information. Any alteration or modification will be subject to verification.

IMC is not responsible for any payment made through individual but not reaching the company.

IMC through its vast range of products gives the Associates an opportunity to start the business. On becoming the IMC Business Associate the products are available at Discounted Rates which can be sold on MRP and the Associate can introduce new people to start their respective business.

To receive income from her/his business, the Associate will have to activate her/his Association ship (ID).

An Associate will have to submit KYC Documents (duly filled Joining Form, Passport Size Photo, ID Card and Residence Proof such as self-attested Copy of Driving License, Passport, Aadhar Card, Voter Card, Pan Card, and Copy of Bank Pass Book or a cancelled cheque) at company's Head Office or will have to upload the soft copy of required documents in her/his profile on company's web site. Once an Associate has earned Sales Volume worth 300 B.V. from the joining date till the closing of 6th month the ID is activated. ID of a person is in RED Colour when the person becomes an Associate, it turns into GREEN Colour after the activation of the ID.

Till the Associate's ID is not activated, no sales incentive will be released. Associate will receive sales incentive only after her/his ID gets activated. If this is not done her/his ID will be automatically deleted. If Associate has any downline, that downline will be rolled up to her/his upline.

To keep the ID active, every Associate has to make some sales volume time to time. If any Associate does not make any sales volume for six months (closing date of sixth month) since her/his last sales, her/his Associationship will be deleted and her/his team will be rolled up to her/his upline and she/he will get no income further.

1. If an Associate does not make any sales volume from her/his last sales till closing date of the fourth month then the company her/his ID Colour will become YELLOW. If this happens the person cannot sponsor any other person. If she/he makes any sales volume, her/his ID colour will again become green (active).

To be entitled to earn a performance Incentive income on downline Volume during a given month an associate whose profit level is 10% to 30% must purchase products worth 500 B.V of personal purchase and an Associate whose profit level is 35% & above must purchase products worth 1000 B.V of personal purchase for using or retailing in that month.

Buy Back Policy :-

If any defect is found in any of the IMC products purchased or if any associate wants to discontinue his associationship with the company then it can either be returned/exchanged within 30 days from the date of purchase. The returned product must be supported with bill of purchase and such product should not be damaged from any angle. The purchaser should ensure that condition of the product should be similar to the condition which was prevailed at the time of purchase.

International Marketing Corporation Pvt. Ltd. at its discretion can change its rules, regulations, policies and procedures as amended by IMC from time to time.


IMC may in its absolute discretion immediately suspend and/or terminate the Business Associationship by notice in writing to the Business Associate in the event that IMC has reasonable grounds to believe that the Business Associate has breached any provision of this agreement, its rules, regulations, policies or procedures as amended from time to time.

IMC shall not be liable for any incidental or consequential damages caused by its breach, cancellation or suspension of this agreement, whether or not the possibility for such damages is known to IMC.

That all disputes or difference arising out of or in relation to this agreement shall be referred to an Arbitrator appointed by the director of IMC whose award shall be binding on the parties in the terms of the provisions of the Arbitration Act.

Jurisdiction in respect of any/all disputes arising out of or in relation to this Business Associate agreement shall vest exclusively in the Courts at Luckhiana only.
